Behavioural difficulties and frustration may be a sign of unmet needs. Whatever the concern or level of need, we can help.

The legal definition of SEN is:

'A child or young person has special educational needs if he or she has a learning difficulty or disability which calls for special educational provision to be made for him or her.

The legal definition of a disability is: 'a physical or mental impairment which has a long-term (a year or more) and substantial adverse effect on their ability to carry out normal day-to-day activities."
